第三条: 认证项目的实施 Conducting certification programs

- 3.1.乙方按认证法规、规则、程序对甲方进行认证审核,在确认管理体系/服务符合合同约定的审核依据后,为甲方办理认证注册,颁发或换发认证证书。新认证或再认证的证书有效期为自颁发之日起 3 年内。Party B shall conduct certification audits in accordance with certification regulations, rules and procedures, and after confirming that the management system/service meets the audit basis agreed in this contract, handle certification registration, issue or renew certificates for Party A. The certificate for new certification or re-certification is valid for 3 years from the date of issuance.
